If you ride 2X in a class, then the 2nd ride must be the HC ride.
4. A \$20.00 fee will be assessed on all returned checks, and no further checks will be accepted until the matter is cleared up.
5. Schooling is available in the arena during breaks. \$10.00 fee for 10 minutes, to be scheduled by the Secretary.
