I waive all rights to sue International Equestrian Organization, Inc., and/or any of their officers, directors, volunteers, employees and agents, the judges at this event, the owners or lessors of the facility where the event is held and/or any sponsor of this event for the injury to/or death of me or where applicable, the junior named above, and/or injury to property, including equines. I agree to indemnify and hold harmless the foregoing parties from and against any and all such claims of injury, death, or damage. This liability/release form is to be construed in accordance with, and to be as broad as permitting by the Equine Activity Immunity Act, Act# 93 of 2005.
